As a Bupa Civil Servants member, you can transfer your membership to Bupa CarePro / Bupa Care Kid, Bupa MyBasic VHIS Plan or Bupa MyFlexi VHIS Plan when you retire, terminate your employment or reach the maximum renewal age, regardless of your health condition. The transfer options are as follows:
